 - a. Information was shared about a number of conservation properties in Holderness.
 - b. The Society will work with M. Capone to find out how and when the town got the Howe property so that they will be able to determine who can grant the easement. They need a copy of the forest management plan. Linda will send Roger electronic copies of Howe Forest information as part of the search.
 - c. Regarding Mt. Prospect, Roger shared that the Pulsifer property (120 acres) has the Burnham Carriage Trail through it that goes up to Mt. Prospect. The Society would like to hold an ownership interest to help protect the forest. Trail work needs to be done to make the Mt. Prospect trails more easily accessible.
 - d. Roger mentioned that the Society wants to work with Alex Ray who owns property next to the Pilote Forest, in hopes of adding more property to Pilote.
