NEW BUSINESS

1. Eversource Z180 Line Steep Slope Application

K. Nelson of Eversource briefed the members on the project to replace 2 poles and build an access road in support of the replacement of the Z180 transmission line that runs from the Huckins Hill Substation in Holderness to the Beede Road substation in Campton. He stated it is a very similar project as to the recently approved project to replace the E115 transmission line. There are three areas in Holderness in which steep slopes will be disturbed and they are seeking comments from the planning board for their application currently pending before the Select Board.

T. D'Aquiar from VHB the engineering consultant on this project, detailed the disturbance areas for the structures and the access driveway to be constructed referring to the plans submitted in their application. There will be approximately 800 sq. ft. of temporary wetlands impact with no permanent

alterations expected. All appropriate erosion and sediment control BMPs will be installed prior to construction and weekly inspections by a wetland's scientist. Additional inspections will be made post storm events to ensure compliance with environmental permits.

R. Huntoon asked if a large storm happens where would the gravel roads wash out to?

T. D'Aquiar replied that the roads will be compacted to specifications that should prevent wash outs up to a 100-year storm. Should any gravel erode, it would remain on Eversource property due to the distance away from the property line.

B. Nesheim asked if the gravel roads will remain upon completion of the project?

T. D'Aquiar responded in the affirmative, the work pads will be reduced from 100' x 100' down to 30' x 60' for space for one truck into the future.

J. Cocchiaro asked what the schedule of construction start-up was?

B. Newell responded that the target is February 20 -23, 2023 during an off-line window.

R. Huntoon asked what was the design of the wetlands matting.

T. D'Aquiar responded that they are bundled timbers, stacked and weaved together, cribbed up and bridged over streams that will allow flow and wetlands to function as they currently do. They are not treated and will be removed within one growing season.

B. Nesheim inquired as to the life span of the new poles and the future capacity of this line.

B. Newell responded that they should last more than 50 years and the capacity is increasing about 300% to a build out date of 2050.

The chair asked for a motion on the project. P. Francesco stated he would abstain from voting as he will be hearing this application as a select board member in January.
