3) Beach –

- Overall, a fine summer with few problems.
 - * Some concern about the slipperiness of the walkway. A wet summer combined with clayey fines working to the surface have made the walkway slippery and is a possible hazard. Discussion followed. Ideas about solutions: place layers of stone or wood chips on top. Wendy will consult with Kevin Colburn.
 - * Wendy brought up question of revisiting the idea of doing more erosion mitigation at the end of walkway. She will contact SLA and SLCS for input.
 - * A few of the Board members and the Beach Attendants received comments about the absense of the swim raft. It appears that we should revisit this question. After much discussion, it was determined that we should first start with investigating with our insurance company as to the viability of having a raft. If the insurance company is OK with us having one we will then investigate options and plan for this in our next budget building process.

4. Program Report -

- Summer Escape No COVID and good compliance from participants!
 - * All sessions were well attended, and Wendy made the point that it would be best to hold the maximum number be 40.
 - * Wendy reported that having no daily registrations was terrific and that she recommends that we make this our policy. Parents will have to sign up for a full week. The Board endorsed this approach.
